

# **“QUICK ASSIST”**

## **MEMORANDUM OF UNDERSTANDING**

This MOU has been designed in a collaborative effort among nine wings within the Northeast Region Civil Air Patrol, a civilian auxiliary of the United States Air Force.

**A. PURPOSE:** The purpose of this MOU is to establish policy for cooperation among the Civil Air Patrol Northeast Region Wings to enhance their common goals of saving human lives and protecting the property and the interests of the citizens of the United States of America.


**B. AREAS OF COOPERATION:** Working within the policy and guidelines of the United States Air Force, Civil Air Patrol and Northeast Region Wings an agreement has been reached to:

- 1 Train with other wings on search and rescue (SAR), Counter Drug, disaster relief, and other mission related activities, approved by their respective wing commanders. This may include participating in training exercises conducted by other wings and providing technical expertise as appropriate.
- 2 Communicate on radio frequencies as approved by the host wing and agreed to by appropriate United States Air Force Authorities.
- 3 Appoint representatives and committees at region and other organizational levels for direct coordination.
- 4 Attend meetings at other wings to encourage mutual education and to exchange information on Air Force mission related activities in which they are involved.
- 5 Provide supplemental mission support to the other wings as requested by the host wing with prime responsibility for the mission. This mission support will be provided as authorized by the appropriate authorities.

**C. MUTUAL ASSISTANCE:** Assistance by NER wings for search and rescue missions or other operations will be in accordance with the National SAR Plan or other appropriate authority. The assisting wing will comply with the regulations and operating procedures of the Civil Air Patrol and State MOU's.

Nothing in this Memorandum of Understanding shall modify or substitute for applicable organizational regulations.


